The foodservice sectors in both Vietnam and Thailand have rebounded from pandemic declines and are expecting to experience growth for the foreseeable future. Restaurants and hotels are seeing increased business as local customers and tourists return, local populations continue to grow, and more middle-class households emerge. This provides great timing to introduce new products from the Western U.S.

- Participating companies will work with project manager and in-market contractor to ship product samples to the market in advance of the demonstration and showcase event. Shipping guidance will be provided following registration.
- A local chef will be engaged in each market to develop recipes for and prepare dishes incorporating participating products. This will include incorporating the western products into local cuisine or featuring them in western-style cuisine appropriate for the local market.
- A promotional event will be conducted for invited trade and media in each market, where the chef will demonstrate and highlight participating western products, with opportunities for product sampling
- Upon completion of this event, participating companies will receive feedback on their products, and any leads from local trade interested in sourcing their products.
