The goal is to help small and medium sized companies from the Western US gather information to help sell their ingredients to food processors, especially food processors in Southeast Asian countries such as Singapore, Thailand, Vietnam & Indonesia.

This work will help companies market their ingredients to food processors. It will also lay the groundwork for participation in future ingredient seminars attended by international buyers and meetings with buyers.

- Provide a sample of at least 5 pounds of your product to research team (adjustments can be made for products used in lower quantities or perishable products)
- Complete an in-take form for culinary team
- Join kick-off meeting (virtual) for your product(s) with culinary team and Project Manager
- Be available to answer questions from culinary team
- Join final presentation of results meeting (virtual)

If interested, please register now. The next 6 companies to sign up will make up the next group of companies for work with the culinary team in June– August. After that companies can sign up for the waitlist to participate in the next available time.
